- : Supply of video based ATCC (Automatic Traffic Counter & Classifier) Machine for Automatic counting and classification of vehicles & training of system.
- 3. Features of the ATCC Machine
- Traffic Study System should be able to run 24 Hours for 3 Days minimum and Do counting and Classification, generate reports in excel.
- 2. The successful Bidder/Consultant shall use Automated Traffic Count and Classification system (ATCC) that can meet the following accuracy levels
 - a) Accuracy in Classification of vehicles should more than 90%.
 - b) Accuracy in Counting of Vehicles should be more than 95%.

If the classification and counting accuracies found below 90% and 95% respectively, then no payment will be made for that assignment.

For verification of above accuracy levels, Audit of Raw ATCC shall be done on a sampling basis.

- 3. Only video based ATCC is allowed, and ATCC should be able to generate screenshots of each vehicle passing by road with vehicle Id used for software counting for proof of validation.
