The intending DPR consultant will have to apply in their letter head mentioning NIQ No. & Dated with valid IT/GST/PT certificate for each documents in a sealed cover to submit to the Executive Engineer (P&RD), Nadia Zilla Parishad on or before 07<sup>th</sup> July 2022 upto 3 PM and thereafter it will be opened in presence of Quotationers who may remain present. The successful Bidder shall be accompanied with the earnest money of Rs. 5,000 (Rupees Five Thousand only) in the form of Bank Draft purchased in favour of the Executive Engineer, WBSRDA, Nadia Division A/C PMGSY.

Rate should be quoted in % (Percentage) basis both in figure & word.

Successful Quotationer will have to execute a formal agreement on non-judicial stamp paper of Rs. 10/-.

The intending Consultant should know that in course of Execute the work to prepare a realistic DPR and BOQ he may performed the following activities associated with departmental Engineers if required.

1. Topographical Survey.
2. Soil Survey.
3. Material Survey.
4. Hydrological Survey.
5. Traffic Estimation Survey.
6. Design.
7. Preparation of Detailed Project Report (DPR).

Surveying along with Geo technical investigation taking Cross Section at least at an interval of 15 Mtrs. for a minimum distance of 500 m on both side of the proposed structure shall be done.

Soil sample should be taken digging at least one bore hole in each abutment / pier location for a depth of 25 mtrs.

Structural design should be authenticated by the competent person.

Water way including G A D (General Arrangement of Drawing) should be vetted by the Director, Central Design Office, I & W Department, Jalasampad Bhavan, Salt Lake City, Kolkata through Executive Engineer, I&WD of concerned division. There after Detailed Project Report along with drawing and estimate should finally be vetted by the competent authority P&RD Department & Jadavpur University, S.T.A. for Nadia District to make the project accepted by P&RD Department.


In DPR, the estimate should be prepared on the basis of schedule of rates of Public Works Department, both for bridge proper and approach road.

Successful agency will have to complete the same with the time stipulated in work order. Rate should be quoted in % (Percentage) on the basis of project cost (Bridge proper).

80% of the total amount will be made available after getting sanction the project from NABARD Govt. of India & Balance 20% of the total cost after issuing work order by the competent authority for execution of construction work.
