Summary of "West Bengal Food Processing Incentive Scheme -21

Objective:-

- To incentivize micro Food Processing Industries in the state having high potential for growth and employment.
- 2. To provide better support system to unorganised Food Processing Sector
- 3. To facilitate Food Processing Industries to adopt GHP, GMP, HACCP and ISO certification norms.
- 4. To promote facilities for post-harvest operation including setting up of F.P. Industries in micro sector.

<u>Funding pattern of WBSFPIS:-</u> WBSFPIS-21 has been designed to assist individual micro food processing unit, Groups and Cooperatives in supporting the setting up of new and up gradation of exiting food processing enterprises.

<u>Convergence with the other schemes of State Government:</u> The concerned entrepreneur for approved project, for which benefits are availed under this scheme, will be eligible for various other incentives or benefits under other scheme of the state Government, except that the benefits by way of State Capital Investment Subsidy will be limited only to one source.

<u>Eligible Sectors:</u> All Micro Food Processing units involved in Food Processing Sector like Fruit & vegetable, bakery and confectionary, milk/meat/poultry/fish products, cereals/ other consumer food products, flour/pulse/ oil milling and other agri-horti sectors including food flavours, colours, oleoresins, spices, coconut, honey, mushrooms will be covered under the scheme.

<u>Eligible individuals/organisations</u>: - Individuals/SHGs/NGOs/Cooperatives engage in establishment/ up gradation/modernisation of food processing units would be eligible for financial assistance.

Quantum of Subsidy: credit link back ended grant in aid @40% of the total cost of plant and machineries of a micro food processing enterprise, subject to maximum limit of Rs. 10 lakh per units.

<u>Receipt of application</u>: - Application are to be made online through the website <u>www.wbfpih.gov.in</u> at least 60 days before start of commercial production process and hard copies off all documents shall have to be submitted in the directorate of FPI (H.Q), GM, DIC, and the FPDO or officer of the Deputy Director of Horticulture.

Document Required: - a) Application in the prescribed format. b) Sanction letter of term loan from bank / financial institution, c) Copy of detailed project report(DPR), d) Appraisal report of Bank/ financial institution, e) Certification of incorporation/ registration of the organisation, f) bio-data/ background of the office bearers/promoters of the organisation., g) Annual report and Audit statement of account of last three year, h) Land parcha(ROR), i) Items wise and cost wise details of technical civil works envisaged dully certified by charter Engineer, j) items wise and cost wise details of Plant & machinery envisaged dully certified by charter Engineer, k) quotation from the supplier of plant and machinery, l) Process Flow Diagram, m) Udyam registration, n) An affidavit duly executed on non-judicial stamp paper of Rs, 100/- or more duly notarised.

<u>Implementation and monitoring of the projects sanctioned</u>:- the implementation scheduled for the projects would be 12 months from the date of the issue of approval letter.
