Cost of Earnest Money should be deposited in Indian Overseas Bank, Krishnagar Branch, Account No. 158301000005555, IFSC Code-IOBA0001583, in favour of FC & CAO, Nadia Zilla Parishad through RTGS/NEFT/CBS system only. The NIA No. and/or UTR No. should be clearly mentioned on the deposit challan. Payment made otherwise will be rejected.


Auction Elapse time is maximum 15 (Fifteen) minutes and Auction Bid auto extensions is also 15 (Fifteen) minutes. The e-auction shall be an ascending forward online electronic auction. Minimum incremental value is Rs. 100000/- (Rupees One Lakh Only) and maximum is 10% of base rate i.e. Rs. 500000/- (Rupees 5 Lakh Only).

The Earnest Money of the unsuccessful bidders to be refunded to their respective bank accounts.

The Eligibility Criteria are given below: -

1. PAN Card, Voter Card [for individual only], and Registration Certificate/Trade license for Firm/Society/Company should be uploaded.
2. No CONDITIONAL/INCOMPLETE auction will be accepted under any circumstances.
3. Before issuance of the Lease Order, the Auction inviting authority may verify the documents of the highest bidder if found necessary. After verification, if it is found that such documents submitted by the highest bidder is either manufactured or false in that case, Lease Order will not be issued in favour of the highest bidder under any circumstances and auction will be treated as cancelled, as well as the Earnest Money should be forfeited in favour of the Nadia Zilla Parishad.
4. Receipt copy of deposit Earnest money should be submitted/uploaded with the tender documents.
5. All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and required.
6. An agreement will be signed between the Nadia Zilla Parishad and the successful bidder to run the Ferry Ghat for three years upon payment of 40% of the bid amount. Rest 60% should be paid in two instalments within next one year and the deposited earnest money will be adjusted only with the last instalment. Failing of any of the above conditions, it will be treated as cancellation of agreement and the Earnest Money will be forfeited.
7. Zilla Parishad will not take any liability and responsibility for any kind of accident / incident during Ferry service.
8. The Nadia Zilla Parishad authority reserves the right to cancel the auction due to unavoidable circumstances.
9. The Nadia Zilla Parishad authority reserves the right to accept or reject any bid or cancel the bidding process, without assigning any reason whatsoever.
10. The successful bidder should abide by the guidelines/orders issued or will be issued in future by Transport Department, Govt. of West Bengal.
