Applications in the prescribed format (attached herewith) with self-attested required documents including resolution of Sangha/ Mahasangha are to be submitted to the respective Block Development Office during office hour (10 AM to 5.30 PM) of all working days till 16th March, 2023.

Necessary Eligibility Criteria for the interested Sanghas are given below:

Essential Criteria:

- The Sangha/ Mahasangha shall have valid registration under West Bengal Cooperative Societies Act 2006 or Societies Act, 2006 with NRLM code.
- ii. The Sangha/ Mahasangha should be of Grade "A" category organization under WBSRLM.
- iii. The Sangha/ Mahasangha shall have PAN card, trade licence (mentioning the nature of business as food Items related) and GST registration.
- iv. The Sangha/ Mahasangha must submit audited balance sheet which has been duly authenticated by the competent authority in all last three Financial Years (2018-19, 2019-20 and 2020-21) one of which must be by Statutory Auditors of Cooperation Audit Directorate.
- v. The Sangha/ Mahasangha must submit proof of filing of Income Tax return for the last assessment year.
- vi. The Sangha/ Mahasangha must submit self-declaration stating that Sangha as supplier has not been debarred / black listed by any government agency including local bodies / PRIs for failure of supply of any food items and also that no case or penal proceedings are pending against them.

- The Sangha/ Mahasangha must have valid Bank account with at least Rs.2.00 lakhs as balance on the vii. date of application and submit Bank account details thereof with a copy of bank statement.
- The Sangha/ Mahasangha must be agreeable to supply food articles in uninterrupted mode at the rate viìi. fixed by Rate Recommendation Committee of WCD & SW Department.
- The Sangha/ Mahasangha must execute a deed of agreement with the SDO, regarding supply of food ix. articles in uninterrupted mode.
- The backup capacity of the Sangha for supplying food items should be of two months. X.

Preferable Criteria:

- The Sangha/ Mahasangha should preferably have its own building with provision of own rented i. godown. In case of rented office building the rented godowns should be clearly identified.
- Preference will be given to eligible Sangha/ Mahasangha having experience of doing the trading ii. business for last 3-5 years.
- Preference will also be given to Sangha/ Mahasangha situated and functioning in jurisdiction of that iii. ICDS project.

Rate Fixation for Supply of Items:

Rate of various items supplied in Anganwadi centres will be fixed on a quarterly basis by Rate Recommending Committee of the WCD&SW Dept. which shall be accepted by the Sangha/ Mahasangha.

Supply of Food Items:

- 1. Supply of Food items is to be made within 7 days after the issuance of supply order by the CDPOs to the concerned Sangha/Mahasangha selected for the Project with a copy to Nodal Officer for the project in the district on behalf of DMMU, WBSRLM.
- 2. The district level Selection & Monitoring Committee (DLSMC) will finalise the sample of Musur Dal in accordance to the norms of Rate Recommending Committee. The sample would be approved sample of reference for SDOs for 1 year in case of no change in the specification of Musur Dal by Rate Recommending Committee in the meantime.
- 3. Supply of food articles would be done to project godowns for which no extra cost would be given.
- 4. Any replacement of food articles if needed due to quality issues shall be made within 7 days.

Payment:

- a. Payment of bills will be done based on the satisfactory performance of Sangha/Mahasangha.
- b. The Sangha/Mahasangha will place the bill to CDPO and it be cleared well within the time frame of one month's time if supply and documents are in order. Regular Payments will be made subject to the availability fund.
- c. The bills will be placed within one week of supply of materials being completed.
- d. Payment related grievances shall be submitted by the Sangha/Mahasangha to the DMMU. The DLSMC will be responsible for addressing genuine grievances.

Others Terms & Conditions:

- Sangha/Mahasangha will have to ensure Supply of food articles i.e. Musur Dal, approved brand of Mustard Oil and lodised Salt at the rate fixed up by the Rate Recommending Committee of WCD&SW ١. Department, Govt. of West Bengal on quarterly basis/ as and when necessary.
- Musur dal will be supplied in gunny bags (in good condition) with net weight of 30 Kgs/ 15 Kgs as per 11. requirement of the CDPO. No torn or worn-out gunny bags will be entertained.
- The Sangha/Mahasangha will have to verify weight of food stuff at the time of supply to the project 111. go-down and weight should be marked on the body of the gunny bags and challan.
- In case the SDO/CDPO finds that sample is not in accordance with the sample approved by the DLSMC, IV. it will be replaced immediately by the Sangha/Mahasangha.

- V. Supply of food articles would be done to Project go-down for which no extra cost would be given.
- VI. Period of contract will be for 1 (one) year normally from the date of execution of contract deed or as the time span fixed by WCD & SW Department. Thereafter they may apply again for renewal. Application for re-empanelment to be done one month prior to expiry of the contact.
- VII. Mustard Oil (Agmark) will be supplied in one litre bottle of approved brands by the Rate Recommending Committee of Dept. of WCD&SW, Govt. of West Bengal. The batch number and expiry date should be clearly mentioned on each bottle. Supply of mustard oil must be done at least four months before the expiry date mentioned on bottles.
- VIII. The lodized Salt will be supplied in one Kg packet of the approved brands by the Rate Recommending Committee of Dept. of WCD&SW, Govt. of West Bengal.
- IX. The Sangha/Mahasangha shall not assign, transfer or let out the contract or any part thereof the supply order to any other Agency.
- X. Under no circumstances the prayer for enhancement of the rate shall be entertained from the approved Sangha/Mahasangha.
- XI. Application Form is available at Block Office, DRDC/DMMU Office, Krishnanagar, district website (nadia.gov.in) and Nadia Zilla Parishad website (nadiazillaparishad.in).
- XII. Only one Sangha will be selected from each ICDS Project.
- XIII. Selection will be based on above mentioned eligibility criteria and the decision of District level electing & Monitoring Committee (DLSMC) is final for selection of Sangha Cooperative.


